Moose received his Bachelor’s degree in Communication on December 13th, 2013. He was named All Academic Big 12 first team for his work in the classroom. He played two years and was a letter winner each of the two. The Sooners won the Big 12 conference his junior year and played in the AT&T Cotton Bowl. Our current balances as of February 1st: Checking Account \$3,097.99, Museum Fund \$81.93, Scholarship Fund \$3,515.31, Sunshine Fund \$10,825.77, General Fund \$1,479.82, Totals \$19,000.82. We need \$634.69 in the Scholarship Fund to be able to pay the 4-Year scholarships that have been awarded to date (\$250.00 each semester to 4 students = \$2,000.00 a year). Postage has again increased so the cost of sending out the newsletter will increase this year, reason we need your correct mailing address, and are considering reducing the cost by sending it via the internet. This year we are showing a film the National Education Association produced in 1959 titled "The Conant Report - How Good Are Our Schools". The film summarizes a study of the American high school by Dr. James Conant the former President of Harvard University. The film compares educational opportunities at Labette County High School and Oakland Technical High School in Oakland, CA (both schools were considered to be model learning institutions - one rural and one urban).

It's hard to believe that it is time once again to share with our alumni. Par for the course, we have had and will have a lot going on here at L.C. Our students and faculty are working hard to be successful.

Often I hear alumni speak of the Trade School Diplomas. Students graduating from LCHS could complete a set curriculum in order to receive a separate diploma. This diploma was sought after by employers and many alumni attribute their careers to this diploma.

Currently, we are working on an initiative which entails the same characteristics as the Trade School Diploma. ACT, the same company which produces the college readiness test has been working over the past two decades to produce a work readiness assessment. This assessment gives employers detailed information about each student's ability to perform in the employment setting. This initiative along with our Vocational programs providing the necessary technical skills will set our students apart from the status quo. Students will be able to walk into an employer with our technical training and a certificate which indicates their level of work readiness, it will set our students apart, much like the trade school diploma did.

I can talk for hours regarding our students past and present successes, the great teachers and the wonderful facilities. However, what makes this school truly special is the sense of brotherhood, family, or kin. For once you walk these halls, you belong to this family for life.

This is demonstrated through the generous donations of our Alumni through scholarships, school projects, service projects and helping students in need of financial support.
