FROM YOUR TREASURER

I am so pleased that I can report that contributions are UP! The total amount received since the last newsletter mailing is at \$12,804.00! Great Job Alumni. Following is how the money received was earmarked: Designated Scholarships \$5755.00; Scholarship Fund \$2700.00; General Fund \$2649.00; Sunshine Fund \$1700.00. I also received \$614.00 for The 506 Foundation, Inc. which I turned over to them. And spent \$11,785.18 as follows: Designated Scholarships \$5870.00; Scholarship Fund \$2250.00; General Fund \$2617.13; Sunshine Fund \$1048.05. Thank you Alumni for making all this happen. Our checkbook balance as of Dec. 31, 2007 was \$7575.14, and we still have a \$5000.00 CD.

The Alumni Banquet was held in the new cafeteria on May 12, 2007. 430 meals were served - a big THANK YOU to our cook, Elaine Phillips and her 'crew'! The Class of '42 met in the Guidance Office, Class of '47 met in the Library, and the Class of '52 met in the Band Room. The Class of 1957 had a great turnout for their 50th class reunion. They started on Fri. night with a Get Together in the Commons Area and continued on Sat. in Haury Hall. The new cafeteria is wonderful, much brighter and bigger. We served 28 Seniors and their parents as our guests. These are the 28 that received scholarships through the Alumni Association, receiving \$12,180.00 in scholarship money.

The Sunshine Fund is going strong. This fund is used to help students who are experiencing hardships through family loss of income, illness, and/or death. Just paying off a lunch bill (in some cases, this is the only hot meal the student gets), or getting to go on a school activity trip, to a little extra cash at Christmas so they can buy Mom a present. This fund also helps the Seniors with those added expenses of cap and gown, pictures, yearbook and announcements. We appreciate and depend on the teachers, counselors, and administration who keep us aware of the needs. I am amazed at how this works. The objective of this Sunshine Fund is to help the student feel 'equal' among his peers, being able to afford Senior pictures, a yearbook, football shoes, etc.
